

Arnold Heidsieck Scholarship

Call for Applications 2024

The **Arnold Heidsieck Scholarship** Fund offers several scholarships for one or two semesters at a university in the U.S. The program invites applications from BA-students in the humanities who are currently enrolled at a German university and have a focus on German literature, language, history and culture. The scholarships provide monthly grants of up to USD 550 and travel allowances of up to USD 1,100.

Arnold Heidsieck (1937-2009), philosopher and German philologist, taught as a professor at the University of Southern California in Los Angeles. Born in Leipzig and raised in Breslau, Heidsieck studied theology in Tübingen and wrote his doctoral dissertation in literary studies at the Freie Universität Berlin. His research initially centered on Kafka and his intellectual contemporaries; his later work focused on German post-war literature and representations of the Holocaust.

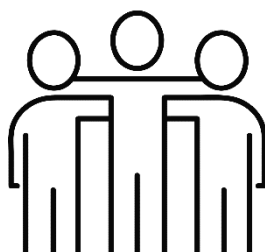

Terms of Reference 2024

1. Scholarships

The Arnold Heidsieck Scholarship Fund will award several scholarships in the U.S. to aid with travel and living costs. The Fund will offer a monthly grant of up to USD 550 for a maximum stay of 10 months, plus a travel allowance of up to USD 1,100.

The Arnold Heidsieck Scholarships can be combined with other sources of funding. If the applicant is the recipient of another scholarship aside from the ZEIT STIFTUNG BUCERIUS, this information must be included in the application.

2. Eligibility

Eligible scholarship applicants must:

- a) Be German or foreign students who are currently enrolled at a German university.
- b) Be BA-students in the humanities with a focus on German culture, language, history, music, or art in their studies.
- c) Be working on their bachelor's degree currently, or travel to the U.S. in the academic year immediately after they have completed their bachelor's degree.
- d) Be accepted to a study stay at a U.S. university.

3. Deadline

The final date for scholarship application is **15 April 2024** for a study stay in the course of the academic year 2023/2024.

4. Information required

The application must be submitted in English on the appropriate form provided by the ZEIT STIFTUNG BUCERIUS before the deadline. It must contain:

- A completed application form
- Curriculum Vitae
- Copy of High School Diploma (Abiturzeugnis)
- Transcript of Records (Leistungsübersicht aus dem BA-Studium)
- Essay explaining your motivations and why you should be considered for a scholarship (max. 2 pages)
- One letter of recommendation from a university professor sent directly from the author (in English or German)

Award recipients will be announced in **May 2024**.

In the case of auditing, personal data may be disclosed. We disclose your personal data to third parties who are involved in the selection of scholarship holders. This may also involve the transfer of personal data to a third country (USA).

4. Information on the storage period and retention period of the data

- a. If you are one of the scholarship holders, we will store your personal data for the documentation of scholarships and the alumni network. If you have not been considered for selection, your data will be deleted after a period of three years.
