INTRODUCTION

Persons with albinism in Tanzania are campaigning in multiple ways against their discrimination and for their recognition as full members of their society. In this context, our cover image shows traditional healers, people with albinism, and members of the Tanzanian parliament coming together for a friendly football match. The picture was taken during field research by Susanne Kathrin Hoff as part of the research project “Un/doing albinism: recodings of a bodily difference through historically shifting frames”, directed by Matthias Krings. It is affiliated with the DFG Research Group 1939 “Un/doing differences: practices of human differentiation”, which also includes Carola Lentz’s research project “Performing the nation and the role of subnational differences in African national days”.

In June, we welcomed Heike Drotbohm as Heisenberg Professor of Social and Cultural Anthropology at our department. Before coming to Mainz, she taught and researched at the Department of Social and Cultural Anthropology at the University of Freiburg. She directs the research project “Politics and practices of eligibility in humanitarian bureaucracies in Brazil”, funded as part of her Heisenberg fellowship by the German Research Foundation (DFG) and conducted in cooperation with the Universidade de Campinas in Brazil. From August to October, Heike Drotbohm was a guest researcher at the New School for Social Research in New York.

Three new research projects were launched in 2016. One of them is “Jihadism in cyberspace: explorations in the aesthetics, reception and adaptation of radical Islamist online propaganda”, directed by Matthias Krings and supported by Bernd Zywietz, Christoph Günther and Michael Erhardt as research staff. The project cooperates with the Violence Prevention Network Hessen (Frankfurt a. M.) and the jugendschutz.net (Mainz). It is funded by the JGU Mainz (“Inneruniversitäre Forschungsförderung”) and the JGU Mainz Center for Intercultural Studies (ZIS). The second new project is directed by Kathrin Langewiesche and investigates, with funding from the DFG, “West African monasteries, transnational networks and alternative economies”. Thirdly, Ulrich Kleinewillinghöfer started a project on “Linguistic research on Adamawa (-Gur) languages of Northeast Nigeria”, also funded by the DFG.

Two research projects were successfully concluded: “The Ahmadiyya movement and Humanity First in West Africa”, directed by Katrin Langewiesche and funded by the Gerda Henkel Foundation; and the DFG-funded project “A grammar of the verb in Mbum (Adamawa language, Cameroon)”, conducted by Holger W. Markgraf under the direction of Raimund Kastenholz.

Throughout 2016, members of the department were involved with the organisation of various international conferences and workshops. Jointly with Vera Hierholzer, the coordinator of the JGU Mainz university collections, Anna-Maria Brandstetter organised an interdisciplinary conference on looted art and other culturally sensitive objects in museums and university collections. Further events included the workshop “The Audio-Visual Communication of Jihadism: Media and Methods of Transnational Radical-Islamic Propaganda”, organised by Matthias Krings, Bernd Zywietz and Christoph Günther. Carola Lentz and Konstanze N’Guessan arranged a panel on “The Un/Doing of National Belonging in African Public Rituals and Performances” at the ASAUK Biennial Conference in Cambridge. Together with Nina Glick Schiller, Heike Drotbohm organised a panel at the biennial conference of the European Association of Social Anthropologists (EASA) in Milan on „Political Subjectivities in the Face of Displacement: Claiming Rights, Belonging, and Social Citizenship”. In cooperation with Jan Beek (Goethe University Frankfurt), Matthias Krings and Cassis Kilian put together a workshop in Frankfurt a. M. on “Fraud, Fake and Make-Believe: Transregional and Transdisciplinary Perspectives”. In the final conference of DFG Special Programme 1448 “Adaptation and Creativity in Africa” held in Potsdam, Thomas Bierschenk organised and chaired a panel on “Critical African Studies”. For the numerous further activities of our staff members as chairs, commentators or organisers of panels, workshops and training courses, please refer to the relevant section of this annual report.

Not only our staff, but also “objects” from our various collections, libraries and archives participated in public events beyond the department. Most importantly, the African Music Archives (AMA), the Ethnographic Collection, and the Jahn Library for African Literatures contributed to an exhibition series organised by the JGU Mainz in cooperation with three major museums in Mainz. They also presented selected objects in various other exhibitions, including “Relation spéciale. 70 Jahre deutsch-französische Wissenschaftsbeziehungen an der Johannes Gutenberg-Universität Mainz”, the JGU Mainz collections’ new series “Ansichtssache! Objektgeschichten aus den Sammlungen” as well as an exhibition at Mainz City Hall celebrating the 70th anniversary of the reopening of the JGU Mainz in 1946, entitled “Die Braut, der Hammer und das Fahrrad. Mainzer Unigeschichten”. Carola Lentz was invited to display a number of her publications on a “red shelf” in the central hall of the University Library and, in connection with that, to present her reading preferences and formative experiences in a special University Library blog from July to November.

In 2016, the Department of Anthropology and African Studies joined a number of other departments of the JGU Mainz all of whom, under the umbrella of the Department of Comparative Literature, contribute to an interdisciplinary M.A. in World Literature established in 2015. Furthermore, musicologist Mitchell Strumpf and Oud teacher Hassan Mahenge from the Dhow Countries Music Academy in Zanzibar, were invited by the AMA and the Musikhochschule Mainz. Funded by the Gutenberg Lehrkolleg, they offered a course, numerous lectures and a concert.

Beyond Mainz, the department participated actively in the Rhine-Main Universities’ strategic alliance. As part of this initiative, in May an impressive number of colleagues from our own and further departments of the JGU Mainz as well as from Goethe University Frankfurt and the Technical University Darmstadt, all working in different disciplines but involved with research on Africa, met in Frankfurt a. M. in order to discuss possibilities of closer cooperation and collaborative research projects. Follow-up meetings included a “Docs and post-docs” workshop for junior researchers in Mainz in October as well as a workshop bringing together senior scholars from Mainz, Frankfurt a. M. and Darmstadt in Mainz in November for a discussion on “Africa in a transregional and transnational perspective”.

In the course of 2016, some colleagues left us: Holger W. Markgraf and Birthe Pater, who has taken up a post at the University of Zurich. However, the department has been fortunate to welcome several new colleagues: as mentioned above, Heike Drotbohm has joined our professorial staff. Michael Erhardt (from March to August), Ulrich Kleinewillinghöfer, Franziska Reiffen, Friederike Vigeland and Bernd Zywiets started work as members of the department’s academic and research staff. Furthermore, Christoph Günther, a scholar of Islamic Studies from the Max Planck Institute for Social Anthropology (Halle), joined the department as a guest researcher and lecturer, contributing to the research project on jihadism in cyberspace. Moreover, we were able to welcome a number of international guests, among them Jasmine Omeke from Harvard University, Solomon Waliaula from Maasai Mara University (Kenya), and Pedzisai Maedza from the University of Cape Town (South Africa). Last but not least, we conducted hearings for two new professorships, one on anthropology and aesthetics and the other on African languages and linguistics. Thus, we look forward to welcoming two new colleagues among our professorial staff in 2017.

ABOUT THE DEPARTMENT OF ANTHROPOLOGY AND AFRICAN STUDIES

The Department of Anthropology and African Studies at the JGU Mainz is an interdisciplinary institution, which covers a broad spectrum of both research and teaching activities. These include social, political, religious and economic anthropology, the politics and sociology of development, media and visual anthropology, modern popular culture, as well as African literatures, African music, theatre and film, as well as the languages of Africa.

Degree programmes offered at the department

The department currently offers a Master of Arts (M.A.) in Anthropology ("Ethnologie"), a Master of Arts (M.A.) in Linguistics with a specialisation in African Languages and Linguistics ("Linguistik – Schwerpunkt Afrikanistik"), a Bachelor of Arts (B.A.) in Anthropology ("Ethnologie"), and a Ph.D. (Promotion) in Anthropology ("Ethnologie") as well as in African Languages and Linguistics ("Afrikanistik").

The focus of the curriculum and research programme is on contemporary Africa. Teaching and research go hand in hand, and advanced students are actively involved in research projects. Cooperation with African universities and collaboration with African colleagues play a central role in all these endeavours.

M.A. "Ethnologie" (Anthropology)

The two-year programme offers research-oriented training in anthropology as a general and comparative discipline in the context of social and cultural studies, which deals with the diversity of human lifestyles, exploring their commonalities and differences. It is closely connected with the department's main research interests and the department's exceptional resources with five professorships and numerous academic staff, the Ethnographic Collection, the Jahn Library for African Literatures, and the African Music Archives. The programme combines a broad engagement with the areas, theories and methods of anthropology on an advanced level in the context of a student research project, supervised by members of the department's academic staff, in which students explore a thematically and regionally specific topic, plan and carry out fieldwork as well as processing, analysing, interpreting and presenting their data. In the course of the student research project, relevant anthropological research methods are acquired and practiced.

B.A. “Ethnologie” (Anthropology)

The three-year programme focuses on the diversity of contemporary cultural and social practices and aims to provide students with a thorough grounding in the methods, theory, and history of anthropological research. While enabling students to explore human practices in all regions of the world, the programme's regional focus is on Africa (south of the Sahara). It integrates the concerns, approaches and methods of anthropology, sociology, history, literary studies, media studies, cultural studies, and linguistics. Students have plenty of scope to develop and pursue their own thematic interests.

The M.A. “Linguistik” is a consecutive programme with a research-oriented profile. Students are required to choose between eight specialisations, one of which is a focus on African Languages and Linguistics, which is offered by the Department of Anthropology and African Studies.

The study of the differences and commonalities of the structures of African languages is at the core of the M.A. “Linguistik – Schwerpunkt Afrikanistik”, which has a functional-descriptive as well as a typological outlook. As a discipline with a special interest in languages with little or no written language documents, African Languages and Linguistics relies heavily on field research, comprising different methods of the acquisition and analysis of linguistic data, including the employment of typological questionnaires.

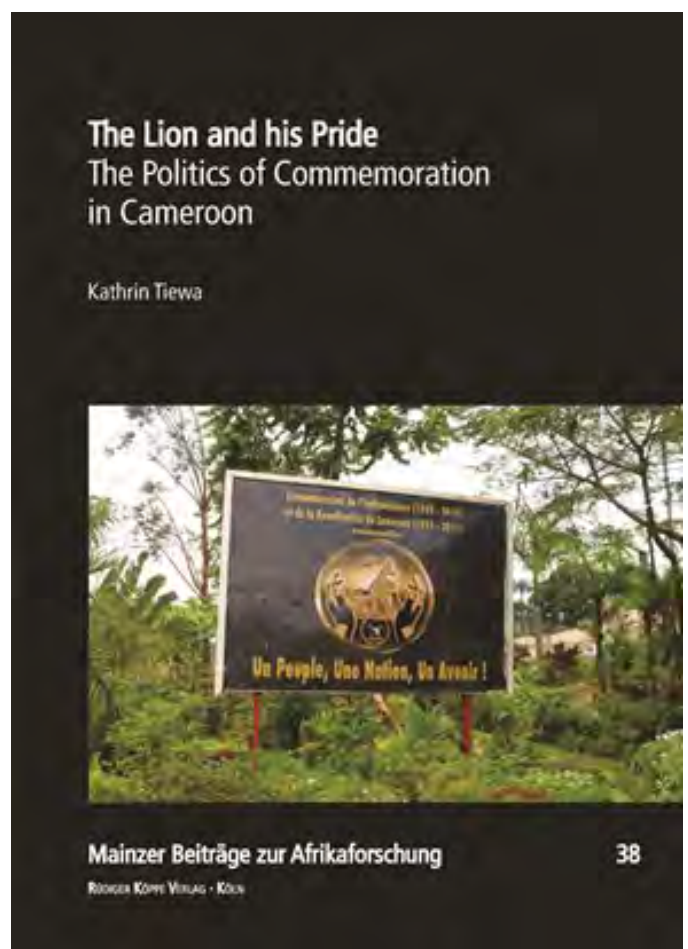

Research facilities in the department

The department's research facilities include the following resources, which are available to students, the faculty as well as other researchers:

- a **DEPARTMENTAL LIBRARY** (Bereichsbibliothek Ethnologie und Afrikastudien), which complements the holdings of the university library and comprises approximately 50,000 volumes as well as about 70 journals.
- the **JAHN LIBRARY FOR AFRICAN LITERATURES** (Jahn-Bibliothek für afrikanische Literaturen)
- the **AFRICAN MUSIC ARCHIVES** (Archiv für die Musik Afrikas)
- the **ETHNOGRAPHIC COLLECTION** (Ethnografische Studiensammlung)
- a **VIDEO ARCHIVE** (<http://www.ifeas.uni-mainz.de/230.php>) comprising ethnographic films, documentaries on African cultures and societies and on current events in the region as well as music clips and African films and film adaptations.
- the **ONLINE ARCHIVE: AFRICAN INDEPENDENCE DAYS** (<https://bildarchiv.uni-mainz.de/AUJ/>), which provides users with full digital access to more than 20,000 images as well as data collected in collaborative research on the Independence Days in twelve African countries.
- the **ARCHIVE: WEST AFRICAN SETTLEMENT HISTORY** (<http://www.ifeas.uni-mainz.de/781.php>) comprising more than 6,000 pages of notes, transcriptions, and translations relating to almost 800 interviews conducted with village elders, earth priests, and village chiefs in the border regions of Burkina Faso and Ghana, as well as further documents from various regional archives.

Jahn Library for African Literatures

The Jahn Library (<http://www.jahn-bibliothek.ifeas.uni-mainz.de>), headed by Anja Oed, is one of the earliest and most comprehensive research facilities for African literatures in Europe and beyond. Its collection comprises creative writing from Africa in more than ninety languages, including classics in African literatures as well as works by less well-known writers and locally produced literary works. The collection also holds translations, film adaptations of literary works and audio-books, as well as a large number of critical sources and academic journals. About every four years, the Jahn Library organises an International Janheinz Jahn Symposium focusing on a central issue in African literary studies, most recently on the African *bildungsroman*.

As one of the JGU Mainz special collections, the Jahn Library participated in an exhibition series organised in cooperation with three major museums in the city of Mainz, “Ziemlich beste Freunde. Die Sammlungen der Johannes Gutenberg-Universität Mainz zu Gast in Mainzer Museen” (<http://www.sammlungen.uni-mainz.de/1458.php>) between 23rd March and 4th September.

One of the Jahn Library’s books – Bakare Gbadmosi and Ulli Beier’s *Yoruba Poetry* (1959) – was displayed in the university collections’ new exhibition series “Ansichtssache! Objektgeschichten aus den Sammlungen”. The book is also featured on the university collections’ website, accompanied by a short essay by Anja Oed entitled “Die stürmische Göttin und der mächtige Elefant” (<http://www.sammlungen.uni-mainz.de/124.php>).

In 2016, the series of showcase displays featuring the literary work of African writers in the 21st century was continued with displays on NoViolet Bulawayo, Marguerite Abouet, and Petina Gappah.

In May, the university’s online magazine, JGU Mainz Magazin, published a report on the Jahn Library, entitled “Literatur jenseits von Klischees und Schubladen” (http://www.magazin.uni-mainz.de/4582_DEU_HTML.php).

African Music Archives (AMA)

Established in 1991, the AMA's record collection focuses primarily on modern music from Sub-Saharan Africa on shellac and vinyl records, CDs and DVDs, video and audio cassettes. Since 2010, when Hauke Dorsch was appointed as head of the archives, activities have focused on four main fields: conserving the records, cataloguing the collection, acquainting students with archival work through exhibitions, workshops and courses, and reaching out to the scientific community through conferences and workshops and to a wider public via media, including newspapers, radio stations and the internet.

In 2016, the AMA's staff was involved in numerous activities: Clémentine Nkongolo continued the digitisation of Congolese singles from the AMA's collection focusing on the transcription and translation of Lingala texts. American Fulbright student Jasmine Omeke finished her research project on the AMA and presented her findings on June 22nd in a seminar.

Records and recordings of the AMA have been used for the exhibition series "Ziemlich beste Freunde" at the Landesmuseum, the Naturhistorisches Museum and the Bischöfliches Diözesan Museum, all located in Mainz, as well as for the exhibition "Kubas afrikanische Geister" at the Museum für Völkerkunde, Hamburg, for the exhibition "Relation spéciale. 70 Jahre deutsch-französische Wissenschaftsbeziehungen an der Johannes Gutenberg-Universität Mainz" at the Schule des Sehens on campus, and for the opening party of the exhibition "Stolen Moments: Namibian Music History Untold" at Iwalewa-Haus in Bayreuth.

On April 8th, Hauke Dorsch represented the AMA at the round table "Analog/Digital. Oral History und Musikarchive in Afrika" with Lars-Christian Koch (Phonogrammarchiv Berlin), Markus Coester (Iwalewa Haus, Bayreuth), and Juan Martin Koch (editor in chief *Neue Musikzeitung*) at Musikmesse Frankfurt a. M.

On May 5th, the AMA organised an enthusiastically received concert of Ebo Taylor from Ghana on campus (Baron), supported by Engagement Global.

From June 7th until July 6th, the musicologist Mitchell Strumpf and Oud teacher Hassan Mahenge from the Dhow Countries Music Academy in Zanzibar, Tanzania, were invited by the AMA and the Musikhochschule Mainz. Funded by Gutenberg Lehrkolleg, they offered a course, numerous lectures and a concert.

Repeatedly, the AMA was represented with DJ sets: on March 8th at the workshop "Adamawa Gur-Sprachen im Brennpunkt afrikanistischer Forschung" at the University of Hamburg with Hauke Dorsch; in August at the "re:boot Africa" event at Planke Nord in

Mainz with Tom Simmert; on July 8th at the department's students' summer festival with Tom Simmert and Hauke Dorsch.

Two generous donations extended the AMA's collection: Paul Nugent, Professor for Comparative African History at the University of Edinburgh, gave a collection of Nigerian singles. In December, Gertrud Mey and Klara Mey donated their husbands' collections of 1970s Cameroonian recordings on reels, LPs and singles as well as manuscripts on Bamiléké dances.

On December 14th, Radio Rheinwelle broadcasted a programme edited by Alexander Chenchenko on the AMA, presenting its collection and some of its recordings.

The AMA's director secured generous funding from the University library for a one-year digitisation project aimed at copying the Archives' music cassettes and shellac recordings. The project is scheduled for 2017.

Ethnographic Collection

Erika Sulzmann started the department's ethnographic collection in 1950. In 1948, she became the first lecturer in Anthropology at the newly established Institut für Völkerkunde at the JGU Mainz and immediately began building up an ethnographic collection. From 1951 to 1954, she spent more than two years in the Belgian Congo (now Democratic Republic of Congo) and carried out fieldwork among the Ekonda and Bolia in the equatorial rainforest, together with Ernst Wilhelm Müller who was a Ph.D. student in anthropology at the time. They collected more than 500 objects, which formed the original core of the department's holdings. Erika Sulzmann constantly expanded the collection during further research trips to the Congo between 1956 and 1980.

Today, the collection encompasses about 2,800 objects mainly from Central and West Africa, but also from Australia, Papua New Guinea and the South Pacific. The collection's items are used in teaching. Students learn how to handle ethnographic objects according to ethical considerations, how to conserve them, and how to design small exhibitions around them. Since 1992, Anna-Maria Brandstetter has been the collection's curator.

In 2015, Thea and Gerhard Anger donated 89 objects to the Ethnographic collection, including 56 figures and everyday objects which they have collected in the 1970s in Burkina Faso and Benin, and 33 baskets acquired between 1983 and 1985 in and around Nyanza (Rwanda). The small baskets *uduseke* are woven by women using raffia or sisal fibres. The technique Inyanja "involves attaching strips arranged horizontally with a string of fine raffia or sisal on several strands that are arranged horizontally" (Kanimba Misago Célestin and Lode van Pee, 2009: *Wickerwork – van-nerie*, p. 40). The finely woven baskets with their almost shiny surface were used for keeping jewellery and other precious personal items. Today, the baskets are bought for decoration by Rwandans and tourists which allows women weavers to create a small income.

As one of the universities' collections, the Ethnographic Collection participated in an exhibition series between 23rd March and 4th September, organised in cooperation with three major museums in the city of Mainz, "Ziemlich beste Freunde. Die Sammlungen der Johannes Gutenberg-Universität Mainz zu Gast in Mainzer Museen" (<http://www.sammlungen.uni-mainz.de/1458.php>).

Ten objects, collected in the context of the research project "The Poetics and Politics of National Commemoration in Africa" (directed by Carola Lentz; <http://www.ifeas.uni-mainz.de/eng/268.php>) are on loan to the Landesmuseum Hannover and feature in the exhibition "Heikles Erbe. Koloniale Spuren bis in die Gegenwart" (30th September 2016 to 27th February 2017). Since 2012, the 153 objects which range from hats, t-shirts and commemorative cloths to cups, ball pens and pennants from ten different African countries have been part of the collection's holdings.

The anthropological research carried out on Christianity in Africa so far has largely neglected monastic life. This project would like to draw attention to the fact that monasticism research not only throws light on little-known aspects of Christianity in Africa, but can also make an important contribution to the understanding of processes of social change and debates on globalisation in African societies.

At the centre of the research project lies a paradox. The contemplative orders aim at retreating from society; however, in order to be able to survive materially as a community, they have to successfully develop alternative economic forms, interact with their environment, and build transnational networks or integrate into them. These interactions are at the core of the research project. Based on the analysis of different religious orders in West Africa, it is framed as an anthropological study on monastic networks, the monastic economy, and social change in precise localised areas in Burkina Faso, Ghana, Togo and Senegal.

Christian institutions in Africa have long been regarded as propagators and symbols of modernity, such as those connected with the establishment of schools or health facilities. Until now, however, monasteries have not been regarded as places of a modern, yet not capitalistic, economic activity.



The project examines contemporary monasteries in West Africa as places where alternative economic systems based on religious values are experimented with. It asks in how far monasteries can be interpreted as pioneers or models for sustainable development in African societies, or at least in parts of these societies.

Un/doing albinism: recodings of a bodily difference through historically shifting frames

Albinism is the medicalised term for a condition that results in a physical appearance with the prominent feature of hypopigmentation of the skin, hair and retina. This appearance deviates from physical norms throughout the world and results in many places in the stigmatisation and discrimination of people with the condition. This project examines the recoding of hypopigmentation through the shift of its interpretative frames – the race discourse, magic, medicine and art – which exist partly in historical succession, and partly simultaneously in different social fields. The shifting of framings is understood here as a contingent effect of changing societal conditions, on the one hand, and a concrete act of undoing which emanates from social movements, on the other.

In 2016, Matthias Krings presented first results at the “Beauty and the norm” conference in Bayreuth. Susanne Kathrin Hoff conducted fieldwork in Tanzania that looked into the social movement created by people with albinism and attended the first UN’s Consultative Forum “Action on Albinism in Africa” in Dar es Salaam. Furthermore, she explored the movement’s relations to traditional healers. In South Africa and the United States, Christopher Hohl began to investigate the aesthetic (re)presentation of people with albinism in fashion and photography. Together with Matthias Krings, both Christopher Hohl and Susanne Kathrin Hoff attended the National Organization for Albinism and Hypopigmentation’s 2016 conference in Pittsburgh, PA (USA), from 14th to 17th July. At the conference, the research team focused on the transatlantic interconnections of actors and concepts within the albinism community.

Performing the nation and subnational differences in African national days

Investigating the cases of Burkina Faso, Côte d’Ivoire and Ghana, the project explores the performance of the nation in national-day celebrations. In everyday life, nationality is a “forgotten” or invisible allegiance which regularly needs to be revived. The project analyses how national-day ceremonies make national belonging visible and palpable by staging its relation to other social affiliations and differences, such as ethnicity, profession, age, gender and political orientation.

By enhancing the project’s comparative analysis of African Independence Days with insights from national-day celebrations in Germany and France and more generally international protocol in Germany both within the military and the Department of Foreign Affairs (planned for January 2017), the project investigates the global dimensions of national ceremonies.

This project explores the situation and experiences of migrants (including labour migrants, non-documented migrants and asylum seekers) who reach a new, unfamiliar place under different social and legal conditions and who receive different types of support and solidarity. More specifically, the project focuses on humanitarian aid and migrant political activism in Brazil (São Paulo), a country whose national history has been shaped by changing trends of immigration and emigration and where identity issues are regularly debated in the context of migration.

Methodologically, the project employs participant observation, following moments of encounters between migrants and members of different organisations and political networks as well as migrants' everyday routines in order to understand how they acquire information and knowledge and how they gain access to political participation. The project pays particular attention to the processes of differentiation that attribute meaning to social categories such as "migrant" or "refugee", but also to "nationality", "ethnicity", "race", "gender" or "age". Thus, it not only contributes to the anthropology of migration and the anthropology of law and bureaucracy but also to an understanding of new forms of South-South migration that are currently still under-researched.

In February and March 2016, Heike Drotbohm conducted research in close collaboration with two humanitarian organisations and in several occupied buildings in São Paulo's city centre. Also, she followed migrant activist groups protesting against the impeachment of Dilma Rousseff's presidency.

Linguistic research on Adamawa(-Gur) languages of Northeast Nigeria

The project aims at decisively advancing the state of documentation and knowledge regarding the Adamawa(-Gur) languages of Northeast Nigeria. The project focuses on the languages of the Nungura-Cluster (aka Longuda), the Bena-Mboi (aka Yungur) Group, the Bikwin-Jen Group, the Tula-Waja Group, and Baa (aka Kwa), which, as a whole, are barely documented. They are spoken in a contiguous area north of the middle Benue, bordering on the region where the terror of militias is seriously obstructing field research at present. The project profits, however, from a sizeable corpus of field notes and recordings which stem from previous field trips of the project director to the area, as well as locally edited literatures. These materials form the basis of the lexical documentations as well as synchronic and diachronic comparative studies of various aspects of the morpho-syntax of the various languages. In order to effectively reach the targeted audiences, the academic community, and the respective linguistic communities in situ, open access publications are being prepared.

In terms of a wider perspective the project substantially contributes to the historical-comparative study of the Adamawa-Gur complex. The as yet hypothetical classification, particularly of the so-called Adamawa languages, requires more robust morphological data.

The project involves close cooperation with scholars, language committees and institutions working on Nigerian Adamawa languages within and outside Nigeria. The project director is an initiator and founding member of the newly established Adamawa Language Studies Group.

Jihadism in cyberspace: explorations in the aesthetics, reception and adaptation of radical Islamist online propaganda

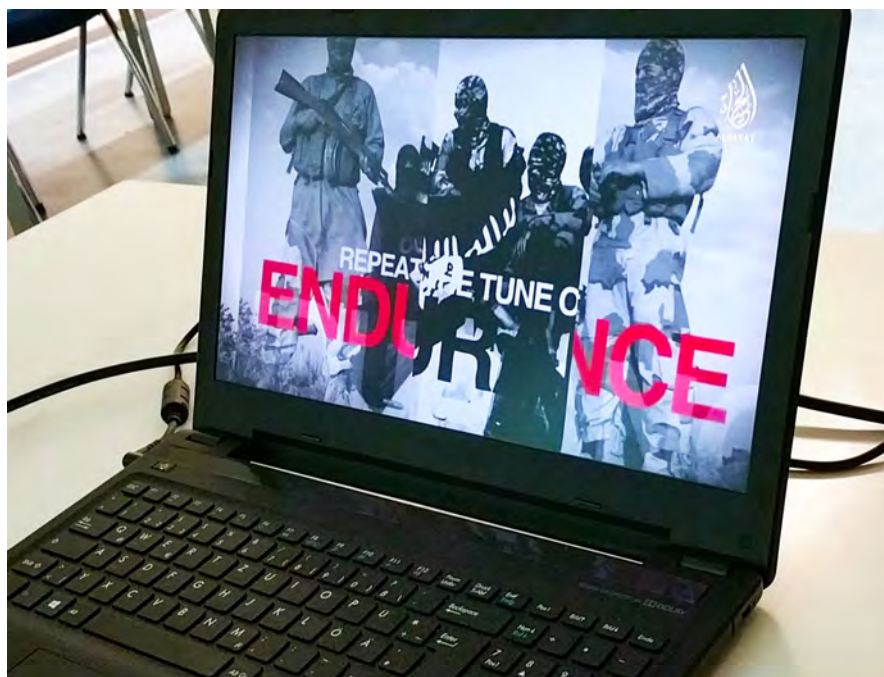

This project analyses jihad-oriented video propaganda and the ways it is interpreted by its multiple audiences in the West. With a strong focus on interdisciplinary collaboration, the project combines conceptual and methodological expertise from media and film studies, Islamic studies, and anthropology. It focuses on the dramaturgical and aesthetic properties of the emerging genre and, by analysing how users of social media platforms share, comment on, adapt and appropriate it, seeks to understand how different groups of social actors make meaning out of it. The project thus not only focuses on forms of audio-visual propaganda disseminated by ISIS and other jihad-oriented Islamist groups but also on its adaptation through images and video clips produced by so-called “prosumers” based in Europe. Through this combination of online ethnography and the close reading of media texts the project hopes to better understand both why jihadist propaganda videos are attractive to some viewers and unattractive to others, and how possible (audio-visual) counter narratives which have already been produced by the latter are designed. Using qualitative methodology and an innovative collaborative video-annotation model the project seeks to complement quantitative research on Islamist media and radicalisation. It hopes to contribute to a better understanding of the potential risks emanating from jihad-oriented propaganda and ways to counter it, as much as to gain a deeper insight into the migration of stylistic elements and symbolic formations across media and cultural boundaries.

The African continent and its coastlines with their enormous potential in oil reserves are now the focus of new explorations and exploitations by multinational and national oil companies. Niger and Chad, land-locked neighbours in the Sahel region, are two of these new petro-states. From a regionally comparative and ethnographically rich perspective, the research project aims to determine which processes of social, political and cultural change – particularly during the early phase – are triggered by oil production and the new flow of oil revenues.



The project aims to add a decidedly anthropological perspective to the economics and political-science dominated expertise on oil in Africa, and aims at producing an anthropology of the African oil-based rentier state. To this end, the project conducts long-term ethnographic studies about social and political practices on the local level as well as processes of signification and the creative adaptation of interpretative and practice-oriented models in relation to oil production.

The project organised a workshop at the final SPP conference in Potsdam in October.

A grammar of the verb in Mbum (Adamawa language, Cameroon)

Focusing on verb and predication in Mbum (Central Adamawa, Kebbi-Benue Group [Mbum Group], Southern Mbum Sub-Group), the project aimed at the monographic description of this Cameroonian language within the framework of a cognitive-functional approach. A phonological analysis of the language is available.

In a typological perspective, the verbal systems of Adamawa Group languages in general and of the Mbum language as a case in point have a number of interesting features: tonal polarity that distinguishes stems with different argument structures, highly complex (phonological) verb words (accumulation of clitic elements, including aspect markers), and a multitude of strategies involving complex predicates in general and, more specifically, serial verb constructions.

A closer look at these latter structures in languages of the Mbum Group will yield important evidence for the description and analysis of serial verb constructions.

Evidence from the related languages Kare (East Kebbi-Benue Sub-Group) and Dii (Central Adamawa, Duru cluster) point to serial verb constructions (henceforth SVC) of the so-called “narrative SVC” type, where motion verbs as part of the structure supply a certain spatial framing to the overall event. SVCs of this type have been documented so far for languages of Papua New Guinea, and are of interest for studies in the field of conceptualising space and time in various languages, including Central Adamawa, and other languages.

The results gleaned from the research can also be used for a typological comparison within Central Adamawa (along with results from the concluded project “Describing Adamawa group languages”), and beyond.

Unfortunately, the project could not be concluded, due to the unstable security situation in Northern Cameroon.

The Ahmadiyya movement and Humanity First in West Africa

This project focused on the religious movement of the Ahmadiyya and their civil-society organisation Humanity First in three West African countries (Burkina Faso, Ghana, Benin). The Ahmadi Community offers a wide range of social services and welfare facilities: in Africa, hospitals, medical camps, schools, student halls of residence and emergency aid; in Europe, calls for blood donations, for the cleaning of public spaces as well as aiding the homeless. Additionally, in 1994 the religious movement of the Ahmadiyya founded its own civil-society organisation: the NGO Humanity First which is dedicated exclusively to humanitarian aims, benefiting the entire population of the countries where they are present.

Humanity First could be described as much as a philanthropic enterprise as an effort to disseminate an Islamic alternative to Christian charity. It is one of the Muslim NGOs, epitomising the tendency of “NGOisation” in the Islamic field, similarly to what has been described for Christian churches. Based on a centralised, state-like organisation with its own administration, a justice court, a proper flag and an international fund collecting board, the Ahmadiyya movement and Humanity First show that an Islamic welfare system can exist parallel to a Christian one in secular states.

21st – 22nd January, JGU Mainz

“Nicht nur Raubkunst! Sensible Dinge in Museen und wissenschaftlichen Sammlungen” [Not only looted art! Sensitive objects in museums and scientific collections]

ANNA-MARIA BRANDSTETTER organised jointly with Vera Hierholzer (coordinator of the JGU Mainz collections) an interdisciplinary conference at the JGU Mainz funded by the Volkswagen Foundation. The aim of the conference was to discuss how to deal with culturally sensitive objects in museum and university collections. These include human remains, cultural artefacts into which human remains have been incorporated, sacred and secret objects and objects with racist or sexist contents, e.g. propaganda material. Furthermore, the debate concerns objects whose conditions of acquisition, origin, production and appropriation are questionable and contested, e.g. cultural artefacts collected during the European colonial expansion, Nazi-looted art or moldings of human bodies or body parts, death masks, audio and video recordings of human voices and anthropological photographs, not to forget illicitly excavated and exported cultural objects and protected species. The conference participants addressed topics like provenance research, the history of collections, the cooperation with originating communities as well as questions of display, access, care and management. The conference brought together curators of university and museum collections with different disciplinary backgrounds, ranging from art history, history, archaeology and cultural anthropology to natural history, biology and physical anthropology. For the first time, the participants explored the issue of sensitive objects and collections considering the specific challenges of university collections from an interdisciplinary comparative perspective and discussed strategies of dealing with sensitive objects and collections (cf. Review by Sarah Fründt, in H-Soz-Kult 26th May 2016: <http://hsozkult.geschichte.hu-berlin.de/tagungsberichte/id=6532&view=pdf>).

“Die audiovisuelle Kommunikation des Dschihadismus. Medien und Methoden transnationaler radikal-islamistischer Propaganda ”

MATTHIAS KRINGS convened jointly with **BERND ZYWIETZ** and **CHRISTOPH GÜNTHER** a workshop on transnational jihadist propaganda, which was funded by the Center for Intercultural Studies (ZIS, JGU Mainz) and the Landeszentrale für Politische Bildung Rheinland-Pfalz, and supported by Frankfurt Research Center of Global Islam (FFGI, Goethe University Frankfurt). In this interdisciplinary workshop scholars of anthropology, media studies, political science, Islamic studies and psychology, joined by social workers and practitioners from governmental and non-governmental institutions (Jugendschutz.net; LKA) discussed the form, content and consumption of audiovisual propaganda disseminated by ISIS and other jihad-oriented groups. A special evening event, open to the general public, was part of the workshop and hosted the screening of a television documentary about the activities of former Islamist Irfan Peci (“Islamist im Staatsauftrag”, ZDF 2015) and a panel discussion with Irfan Peci, Elmar Thevesen, Susanne Schröter, Asiem El Difraoui, and Christoph Günther.

“Political Subjectivities in the Face of Displacement: Claiming Rights, Belonging and Social Citizenship”

HEIKE DROTBOHM co-organised together with Nina Glick Schiller a panel at the Conference of the European Association of Social Anthropologists (EASA).

8th September, Cambridge (UK)

“The Un/Doing of National Belonging in African Public Rituals and Performances”

CAROLA LENTZ organised jointly with **KONSTANZE N’GUESSAN** a panel, sponsored by *Africa, Journal of the International African Institute*, at the ASAUK Biennial Conference 2016 in Cambridge (UK). The panel explored the ways in which national belonging is staged, downplayed or emphasised in public rituals and performances. “Fraud, Fake and Make-Believe: Transregional and Transdisciplinary Perspectives”

MATTHIAS KRINGS and **CASSIS KILIAN** convened jointly with Jan Beek (Goethe University Frankfurt) an international and interdisciplinary workshop which focused on fraudulent social interactions and the discourses surrounding them in global capitalism, politics and art. The workshop was meant to serve as a stepping stone for the joint development of a field of study, bringing together scholars from the social sciences and the humanities, using fraud as a lens to explore an increasingly transregionally connected world. From December 2015 to February 2016, **MATTHIAS KRINGS** and Steffen Köhn (FU Berlin) curated the exhibition: “Always-on. Sehen und gesehen werden in einer vernetzten Welt” (Schule des Sehens, JGU Mainz, 11th December to 4th February 2016). Its aim was to present some of the questions and concerns of contemporary media anthropology to a wider audience and to make an original anthropological contribution to the exhibition programme of the Schule des Sehens, a new public outreach institution of the JGU Mainz. The exhibition explored a technological device and its current cultural impact: the webcam, a new medium that not only allows for a staging of the self but is also at the centre of current discussions about big data and surveillance. The exhibition presented seven webcam-based works of media art that each addressed the blurred boundaries between the public and the private, between consumption and new forms of digital surveillance and between voyeurism and exhibitionism.

In March, **UTE RÖSCHENTHALER** organised with Augustin Emame, Ibrahima Tchioub and Moussa Sissoko the Point Sud workshop “Making a Better Life: Training, Work and Mobility of Youth in West and Central Africa”, Bamako, 2nd – 8th March.

Between 23rd March and 4th September, the **African Music Archives**, the **Ethnographic Collection**, and the **Jahn Library for African Literatures** participated in an exhibition series organised in cooperation with three major museums in the city of Mainz, “Ziemlich beste Freunde. Die Sammlungen der Johannes Gutenberg-Universität Mainz zu Gast in Mainzer Museen” (<http://www.sammlungen.uni-mainz.de/1458.php>). Objects from our three collec-

tions (as well as objects from other JGU Mainz collections) were guests in the permanent exhibitions of the Landesmuseum Mainz, the Naturhistorisches Museum and the Bischöfliches Dom- und Diözesanmuseum. Objects from the university's collections and archives, which are extremely diverse in terms of their aesthetic, cultural and conceptual value and many of which are normally used in teaching and research, were selected for this project to enter into a dialogue with objects displayed in the various sections of the three museums. Different cultures and eras, academic disciplines and living environments, stories and histories, styles and materials met and engaged with one another in fascinating and surprising ways. Visitors of the permanent collections were invited to see the objects of both the university collections and the museums in a new light, to develop new perspectives and to make own associations.



Between March and September, **ANNA-MARIA BRANDSTETTER** participated in an exhibition seminar to prepare an exhibition on the everyday history of the University of Mainz, jointly taught by Christian George, Kirsten Grimm, Vera Hierholzer, Patrick Schollmeyer, Mirko Uhlig and Anna-Maria Brandstetter. Twenty-eight students in history, art history, cultural anthropology, geography, archaeology and other disciplines were involved in the preparation of the exhibition and contributed with their research and texts on object biographies to unique insights into the “microcosms of the university”. The exhibition, entitled “Die Braut, der Hammer und das Fahrrad. Mainzer Unigeschichten” at the Mainz City Hall (16th September to 9th November), was part of the activities to celebrate the 70th anniversary of the reopening of the university in 1946. Curated by Vera Hierholzer with Christian George, Kirsten Grimm and Patrick Schollmeyer, the exhibition was the result of the cooperation between the University Library, the University Archive, the coordination of the university’s collections, the Schule des Sehens, the Department of Anthropology and African Studies and the Department of Film, Theater and Empirical Cultural Studies. Anna-Maria Brandstetter co-curated jointly with Christian George (JGU Mainz) the displays on “Protest and solidarity”.

HAUKE DORSCH provided records and texts for the exhibition series “Ziemlich beste Freunde” coordinated by Vera Hierholzer at the Landesmuseum, the Naturhistorisches Museum and the Bischöfliches Diözesan Museum, from 23rd March to 4th September.

HAUKE DORSCH, MELISSA MÖLICH, LUKAS SAUER, KATHARINA VOLKMANN, MARKUS COESTER and the staff of “Baron Mainz” organised the concert of Ebo Taylor (Ghana) in “Baron” on campus, Mainz, on 5th May.

KATRIN LANGEWIESCHE organised with Isabelle Jonveaux the panel “Monasticism Outside Europe” at the Third International Monastic Symposium, “Monasticism and Economy: Rediscovering an Approach to Work and Poverty”, Rome, Pontificio Ateneo S. Anselmo (7th – 10th June).

It was also a finalist for the Orwell Prize, the Art Seidenbaum First Book Award, the Frank O'Connor International Short Story Award and Zimbabwe's National Merit Award.

Narrated from Chikurubi Maximum Prison by the only woman in Zimbabwe on death row, *The Book Of Memory* has been described as a "compelling and haunting novel about the impossible and extraordinary things that people do for love, and the inexorable power of fate." *The Book Of Memory* has been longlisted for the inaugural edition of the Financial Times/Oppenheimer Funds Award. In addition, Goldsboro Books, the largest seller of signed first editions, has selected it as the Book of the Month for September 2015, an accolade it confers on books that it considers "highly enjoyable and potentially collectable".

Rotten Row, to be published in November 2016, is a short-story collection that explores the causes and consequences of crime through a panoramic view of Zimbabwean society. Dissecting lives as diverse as *malwezi*, Harare's infamous conductors, market women, sharp-suited lawyers, garrulous magistrates, loyalist rural chiefs, corrupt policemen, disgraced teachers, power-hungry security guards, small houses, good time girls and other flawed and fragile characters, Petina crosses the barriers of class, race, gender and sexual politics to meditate on the nature of justice in a collection that is laced with humour and infused with kindness.

CAROLA LENTZ serves as head of department of the Department of Anthropology and African Studies since October. 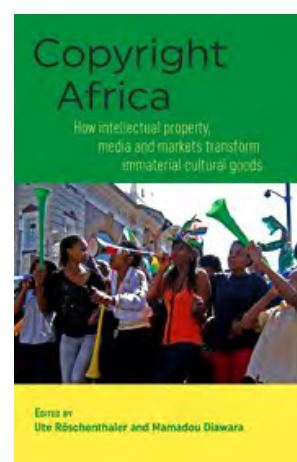
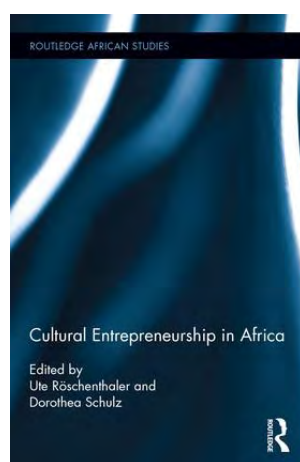
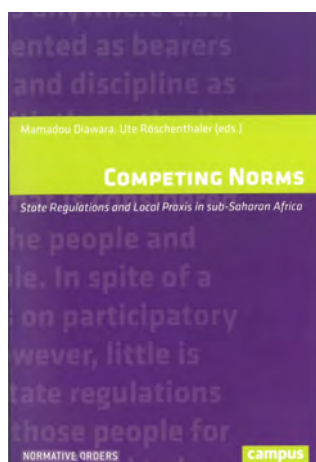

The department cooperated with University of Zurich through the Swiss-European Mobility Programme. One student went to Zurich for the 2016/17 term.

RMU – Rhine-Main-Universities

As outstanding research universities in the Rhine-Main area, the Goethe University Frankfurt, the JGU Mainz, and Technical University Darmstadt have formed the strategic **RHINE-MAIN-UNIVERSITIES** alliance (RMU), and in December 2015 entered into a framework agreement for future close cooperation. As part of this cooperation, on May 20th, the presidents of the JGU Mainz and the Goethe University Frankfurt as well as the deans of the two relevant faculties signed a cooperation agreement concerning African studies, and more specifically African languages and linguistics, establishing guidelines for coordinating future professorial appointments as well as developing a joint curriculum. Beyond this specific agreement, further departments and institutions at all three universities that are concerned with research on Africa created a new network, called Afrikaforschung Rhein-Main (Africa Research Rhine-Main), which exchanges information on ongoing activities and encourages the development of new collaborative research initiatives with regard to Africa. Altogether two departments of the Technical University Darmstadt, nine departments and institutions of the JGU Mainz, and thirteen departments and institutions of the Goethe University Frankfurt form part of this network. At IfEAs, Sabine Littig has agreed to represent the department in this initiative and coordinate the flow of information.

First initiatives included a meeting in October in Mainz of doctoral students and post-doctoral researchers from a broad range of disciplines at all three universities in order to create a young researchers' network; a next meeting will be held in February 2017 in Frankfurt a. M. The aim is to develop a larger project of workshops, conferences and training courses for young academics. In November, a group of senior researchers interested in trans-regional research met and discussed perspectives of developing joint project proposals. Further plans include cooperation in teaching and study programmes such as a new joint BA programme of African languages and linguistics.

STUDENT STATISTICS

In the winter semester of 2016/2017, the Department of Anthropology and African Studies had **694 STUDENTS IN TOTAL**, including students enrolled in one of the B.A. or M.A. programmes as well as numerous Ph.D. students.

B.A. programmes

In the winter semester of 2016/2017, 649 students were enrolled for the **B.A. IN ANTHROPOLOGY (“ETHNOLOGIE”)**. Of these, 234 were studying it as their major subject (Kernfach) while 415 were studying it as their minor subject (Beifach).

In the summer semester of 2016, 125 B.A. students were enrolled in their first semester (46 with Anthropology as their major and 79 with Anthropology as a minor).

In the winter semester of 2016/17, 105 B.A. students were enrolled in their first semester (42 with Anthropology as their major and 63 with Anthropology as a minor).

37 students finished their B.A. in 2016. For a list of B.A. theses completed in 2016, see pp. 57ff.

M.A. programme

In the winter semester of 2016/17, 22 students were enrolled in the **M.A. PROGRAMME IN ANTHROPOLOGY (“ETHNOLOGIE”)**, a slight increase from the preceding year.

Magister artium programme

In the winter semester of 2016/17, 23 students were still enrolled in the **MAGISTER ARTIUM**, which is being discontinued. Of these, 19 students were studying **ANTHROPOLOGY (“ETHNOLOGIE”)** and 4 students were studying **AFRICAN LANGUAGES AND LINGUISTICS (“AFRIKANISCHE PHILOLOGIE”)**.
