 - You will need your German social security number for that (on your pay roll look for Sozialversicherungsnummer or Rentenversicherungsnummer)
 - Get the SSR no. via https://ssr.bfs.de/ssrportal
 - Keep a PDF-copy of the certificate and send it to P. Blümler (bluemler@uni-mainz.de).

2. Determine your radiation safety category:

possible dose per year	> 6 mSv	1-6 mSv
physical examination	yes	not necessary
examples	TRIGA reactor, working with very strong sources	Visitors at BESSY, DESY, CERN, etc.

If you are category A: You must have a physical examination at the University Clinics (extra sheet!). You need the pass book before you go there (page 12/13!)

3. Get a Radiation Passbook

Depending on your research group you might get one from the secretary or you need to order it (e.g. from Fachverlag König, Art. Nr. 5250E Strahlenpass, http://www.koenig-verlag-muenchen.de/Strahlenschutz.htm).
